



Errors and Omissions Insurance for UKTV commissioned productions

Introduction

The arrangement of suitable E&O Insurance is required by UKTV on all their commissioned productions.

The E&O insurance should commence from the delivery of the production to UKTV and name *UKTV Media Holdings Limited and Subsidiaries* as an additional insured. The E&O insurance should be worldwide policy, for a minimum period of 3 years and provide a minimum claim limit of £1 Million per claim and £3 Million as a policy aggregate limit. The policy should be on a 'Claims Made' basis.

Quartz Insurance Brokers Limited has arranged a comprehensive E&O insurance facility to be used by production companies commissioned by UKTV. The premium currently for the three year policy is £650 plus insurance premium tax.
